COURSE DESCRIPTION

Slope Rescue is a scenario-based rigging course used to further develop the student's understanding in technical rigging for vertical environments. Students are introduced to re-directs two person life-loads, advanced anchoring and rigging procedures. Students revisit and implement Wilderness First Responder procedures in a scenario-based slope rescue.

Short Practical Skills Courses (16 hours or less): Students must attend all days/hours in order to be eligible to pass the course. Missing any portion of a short course will result in the student failing that skills course.

Knowing due dates for assignments and meeting these dates. ALL assignments must be submitted on or before the due date. Any assignment handed in late will be penalized 10% per day. Assignments that are 7 (seven) days or more overdue will be given a grade of 0 (zero) yet must still be completed and submitted. Failing to submit a required assignment will result in an overall course grade of 'F'. All assignments must be

submitted in class, in proper format. Extraordinary circumstances: "Wherever possible, students are expected to anticipate their need for special allowances, and enter into discussion and make necessary arrangements with the appropriate faculty member (or other academic officer) in advance of the situation.
